

Terms and Conditions

If you have participated in **VIA & Cartrack: Veilig op die Pad** competition please familiarise yourself with the following Terms and Conditions:

- 1) The promoter is Cartrack (Pty) Ltd whose registered office is at 13 Keyes Avenue, Rosebank, Johannesburg, South Africa.
